 - Suggested to advertise earlier 3 to 4 months ahead
 - More Radio PIA at better time of day
 - Utilize the Public School "Connect Ed" Messaging system
 - Provide 2 Mobile Vaccine Projects a year (one in Spring and one end of Summer)
 - Karoline Jones is active in her local Vaccine Coalition which also provides a Mobile Vaccine Program. She will provide contact for obtaining information about their best practices for their Mobile Projects. This information could be helpful in our future planning and programming.
